# WAIVER, RELEASE OF LIABILITY & CONTRACT

In exchange for participating in the activity of dancing organized by Triple Threat Dance Studio, and/or use of the property, facilities and services of Triple Threat Dance Studio, I agree for myself and (if applicable) for the members of my family, to the following:

**ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Triple Threat Dance Studio for injury, loss, or damage arising out of my or my family's use of or presence upon the facilities of Triple Threat Dance Studio, whether caused by the fault of myself, my family, Triple Threat Dance Studio or third parties. I further agree to indemnify and hold harmless Triple Threat Dance Studio and all other listed for any and all claims arising as a result of my engaging in or receiving instruction in Triple Threat Dance Studio, LLC. Activities or any activities incidental thereto, whenever, wherever or however the same may occur. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury, sickness or disease to myself and (if applicable) my family members, and further release and discharge Triple Threat Dance Studio for injury, loss, or damage arising out of my or my family's use of or presence upon the facilities of Triple Threat Dance Studio, whether caused by the fault of myself, my family, Triple Threat Dance Studio or third parties.

**INDEMNIFICATION.** I agree to indemnify and defend Triple Threat Dance Studio against all claims, causes of action, damages, judgments, costs, or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of Triple Threat Dance Studio. **INSURANCE POLICY:** Triple Threat Dance Studio does not carry medical insurance for our students. Our policy requires that all students be covered by their own family insurance policies and if injury occurs, students will only be covered under their own policy. Student's own insurance will be the only source of reimbursement. **FEES.** I agree to pay for all damages to the facilities of Triple Threat Dance Studio caused by any neglect, reckless, or willful actions by me or my family. **DISPUTE RESOLUTION.** The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure. Any legal or equitable claim that may arise from participation in the above shall be resolved under North Carolina Law. Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rule of mediation is not successful in resolving the entire dispute or is unavailable, any outstanding issues will be submitted to final and binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and judgement may be entered upon it any any court having proper jurisdiction. **COSTUMES.** All costumes must be paid for in full before sent home with student. There is a separate costume for each performing class (excluding tumbling, technique and F.D.T.A.) **Once costumes are ordered, there will be no exchanges or refunds. TTDS holds the right to withhold any costumes for accounts not up to current.** **COLLECTIONS.** In the event that Triple Threat Dance Studio must retain a collection agency or law firm to collect past due balances owed to Triple Threat Dance Studio, you agree to pay any and all collection agency fees, court costs, attorney fees or incidental cost associated with collecting. **MONTHLY TUITION INSTALLMENTS.** Monthly tuition installments are due on the 1st of each month and late on the 16th where a \$10 late fee is automatically charged on to the account. If account remains past due leading onto the following month, a 2nd late fee is charged to the account. **SUSPENSION / WITHDRAW/CANCELLATION.** There is a \$50 cancellation fee to cancel your contract and remaining installments. To cancel, you must notify us within 4 weeks of the next tuition due date as well as making sure all fees on the account are paid for up to current. Fees on the account will continue to accumulate until the account is up to current and cancellation fee is paid. **RIGHT TO DECLINE** TTDS holds the right to decline or suspend any student from any class, program or performance event due to the following, but not limited to inappropriate behavior, disrespect or recurring negative behavior from student or parent, multiple tardies, multiple absences from class, recurring bullying in class, gossiping in class. No refunds will be given for classes that student is suspended from.

# OUR STUDIO POLICY

## Triple Threat Dance Studio

*Breaking our studio policy may result in suspension of our program.*



**STUDIO ETIQUETTE:** There should be no walking through classrooms when classes are in session. Any visits to the restrooms or break room should only be done in between classes to minimize class disruptions. Helping to keep the studio clean and picking up after yourself and your children. Triple Threat Dance Studio has a no bullying tolerance. This applies to all TTDS members and families. One thing TTDS is known for is the positive environment we create. We expect all parents and students to have a positive attitude and to treat all members with respect while present inside and outside our studio. TTDS holds the right to suspend any students or participating parties taking part in bullying.

**CLASS-WEAR:** Students must wear the correct dance wear required for each class. Hair must always be pulled back out of face before participating. We have a "Getting Ready Area" located in our student break room for students to pull back their hair. Students are repressible for providing their own hair bows and hair brush.

**RECITAL:** All students in performing classes, which includes all classes aside from tumble, technique and F.D.T.A., are required to perform in the end of season recital in June. Recital date and information will be available by October. Students will have their recital pictures at the studio in May leading up to our recital event. Students are required to participate in recital photos; however, purchasing of photos are optional.

**COSTUMES:** There is a separate costume for each performing class, excluding tumble, technique and F.D.T.A.. Recreational costumes cost an average of \$75 to \$95 per costume. Costume price does not include shoes. All dance shoes, aside from hiphop & cheer shoes, can be ordered through TTDS. A sizing kit is available. All costumes must be paid for in full before sent home with student. Once costumes are ordered, there will be no exchanges or refunds. TTDS holds the right to withhold any costumes for accounts not up to current. **All costume & Recital fees are due by MARCH 6TH, 2024.**

**COMMUNICATION:** Triple Threat Dance Studio will post very important information on our info wall located in our lobby, on the Team Reach App and via email. All TTDS Family members are required to download this app and join our studio group. It is your responsibility to keep track of the upcoming events and due dates. Any and all payments that are made after due dates are subject to late fees. You can call our studio phone at **704-855-0005** during our operating hours. All questions and concerns through the season can also be communicated via email at **info@triplethreatds.com.**

**PARENT INFRACTIONS:** Some examples are listed here. Talking unkindly to any staff or students. Gossiping at the facility. Raising voices in an inappropriate manner in classroom or at an event. Interrupting classrooms or discouraging other students. There should be NO PARENT OR STUDENT observations in classrooms, but will be considered on a per basis issue (example: Grandmother in town, 1st time visitor, etc.).

**ABSENCES/TARDIES:** Please arrive on time and attend each class. Students are granted 3 unexcused absences per half season and unlimited excused absences (school event, doctor/dentist visits, sickness or injury, and church events). **If a student misses more than 6 classes, excused or unexcused, he or she may be required to take a private lesson with his/her instructor at \$20 per 30 min private lesson to catch up. It is also recommended to take a private lesson if a student misses 2 weeks of class in a row.** Please understand that absences and tardiness can hold back an entire class. Please use the team reach app to send a direct message to your instructor if you will be missing class.

**MONTHLY TUITION INSTALLMENTS.** Monthly tuition is due on the 1st of each month and late on the 16th where a \$10 late fee is automatically charged on to the account. If account remains past due leading in to the following month, a 2nd \$10 late fee is charged to the account. Monthly tuition remains the same whether it is a short 2 to 3 week month or a long 4 to 5 week month.

**PAST DUE ACCOUNTS:** After an account is past due 2 months and monthly tuition payment has not been received, student will **NOT be allowed** to participate in class until account is up to current with amount due, including late fees. All payments made after due dates subject to a late fee. Late fees are \$10 - \$25 per late fee. **Accounts must be up to current BY June to participate in the Recital.**

**UN-ENROLLMENT/WITHDRAWAL/CANCELLATION:** In order to un-enroll from the program and to cancel your contract and remaining tuition installments, the parent/guardian on contract **MUST** pay all tuition, costumes & fees up to current **as well as a \$50 cancellation fee to close the account.** Account will remain open and will continue to accumulate fees (including late fees) until settlement is received **at least 4 weeks before next tuition date.** Accounts left with an open balance and is un-responsive to emails and notices are subject to be sent to our collections agency. Triple Threat Dance Studio purchases costumes and make payments on your behalf to the companies we use for costumes, awards, venue, recital, etc..
