

*REGISTRATION FEE AND ANY ADD ONS/PACKAGES MUST BE PAID FOR IN FULL UPFRONT. REGISTRATION FEE & ANY ADDITIONAL PACKAGES OR ADD ONS ARE NON-REFUNDABLE.

1. Pay by cash, check or card in studio each month for tuition installments. You will be responsible for making your monthly tuition installment payments on the 1st of each month and no later than the 15th of each month. Late fees apply on the 16th & again on the 1st of the following month.
2. Pay in full in 1 single payment & receive a 10% discount on tuition (11 months) Available 1st month ONLY
3. Put a card on a file for your monthly tuition installments to be automatically charged on your card each month (processing fee applies).

Students are not allowed to participate when account is 1 month past due or if competition fees are past due.

Activities or any activities incidental thereto, whenever, wherever or however the same may occur. Student's own insurance will be the only source of reimbursement. **FEES.** I agree to pay for all damages to the facilities of Triple Threat Dance Studio caused by any neglect, reckless, or willful actions by me or my family. **DISPUTE RESOLUTION.** The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure. Any legal or equitable claim that may arise from participation in the above shall be resolved under North Carolina Law. Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rule of mediation is not successful in resolving the entire dispute or is unavailable, any outstanding issues will be submitted to final and binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and judgement may be entered upon it any any court having proper jurisdiction. **COSTUMES.** All costumes must be paid for in full before sent home with student. **Once costumes are ordered, there will be no exchanges or refunds. TTDS holds the right to withhold any costumes for accounts not up to current.** **COLLECTIONS.** In the event that Triple Threat Dance Studio must retain a collection agency or law firm to collect past due balances owed to Triple Threat Dance Studio, you agree to pay any and all collection agency fees, court costs, attorney fees or incidental cost associated with collecting. **SUSPENSION / RIGHT TO DECLINE** TTDS holds the right to decline or suspend any student from any class, program or performance event due to inappropriate behavior, disrespect or recurring negative behavior from student or parent, multiple tardies, multiple absences from class, recurring bullying in class, gossiping in class. No refunds will be given for classes that student is suspended from. **PAST DUE ACCOUNTS** After an account is past due 2 months and monthly tuition payment has not been received, student will not be allowed to participate in class until account is up to current with amount due, including late fees. All payments made on any account, Event fee , costume fee or item is subject to a late fee. Late fees are \$10 - \$20 or percentage of amount owed to Triple Threat Dance Studio. All fees past due on an account is subject to be sent to collections. **Accounts must be up to current through December to participate in the Christmas Program. Accounts must be up to current in May-June to participate in the Recital.**

UN-ENROL/ WITHDRAW FORM: In order to withdraw from any of our programs, parent/guardian on contract MUST complete the withdraw form and pay all tuition, costumes & fees up to current. Account will remain open and will continue to accumulate fees (including late fees) until withdraw form is completed and turned in with settlement to close account at least 30 days before next tuition date. Accounts left with an open balance and is un-responsive to emails and notices are subject to be sent to our collections agency. Triple Threat Dance Studio purchases costumes and make payments on your behalf to the companies we use for costumes, awards, recital, etc..

***By signing below I understand and agree to all the statements listed above as well as all agreements for monthly installment fees. I agree to pay for my child's monthly tuition installments, his/her costumes, recital fees and all other event related fees required for the remainder of the season. I understand that there is a separate costume for each performance class that my child is in (Excludes tumbling, technique and FDTA). TTDS does not give refunds and is not required to give any refunds or exchanges on any costumes, classes or events. We have a "No Refund Policy" on all costumes. I do hereby acknowledge and agree that my child's dance photograph and/or dance video may appear on Triple Threat's website or other social media platforms run by TTDS. I understand that I am held accountable to helping TTDS create a positive environment for all. By signing below, I agree and understand that I am responsible for making all monthly payment installments through the payment method selected above for the remainder of the season. I understand that tuition is due on the 1st of every month and I also understand that a \$10 late fee will be applied to payments made after the 15th and an additional \$10 late fee will be applied to payments made after the 1st of the following month. I understand that if my child drops-out of the program at any point during the year, or is suspended for any reason, then I will have to complete the withdraw form and pay the \$50 withdraw/un-enrollment fee, as well as all tuition, costume, event and recital fees up to current in order to keep my account from accumulating fees. I also understand that if I have paid for my account in full and my child drops-out during the year, or my child is suspended during the year, my refund will only amount to half of my remaining balance and the withdraw fee will be deducted from my refund. Any accounts left with unpaid balances will be sent to collections. I understand that my tuition must stay up to current. Once my tuition is more than 1 month late, I understand that my child may not be allowed to participate until account is up to current.

OUR STUDIO POLICY BELOW

Breaking our studio policy OR the competition contract may result in suspension of our program.

STUDIO ETIQUETTE: There should be no walking through classrooms when classes are in session. Any visits to the restrooms or break room should only be done in between classes to minimize class disruptions. Helping to keep the studio clean. Parents should encourage not only their own student, but others as well. Students should also encourage one another. Triple Threat Dance Studio has a no bullying tolerance. This applies to all TTDS members and families. One thing TTDS is known for is the positive environment we create. We expect all parents and students to have a positive attitude and to treat all members with respect while present inside and outside our studio. TTDS holds the right to suspend any students or participating parties taking part in bullying or gossiping about other TTDS members at our facility.

CLASS-WEAR: Students must wear the specific dance wear required for each class. Hair must always be pulled back out of face.

COMMUNICATION: Triple Threat Dance Studio will post very important information on our info wall located in our lobby and on the Team Reach App. All TTDS Family members are required to download this app and join our studio group. It is your responsibility to keep track of the upcoming events and due dates. Any and all payments that are made after due dates are subject to late fees. All questions and concerns throughout the season should be communicated via email at info@triplethreats.com

PARENT INFRACTIONS: Some examples are listed here. Talking unkindly to any staff or students. Gossiping. Raising voices in an inappropriate manner. Interrupting classrooms or discouraging other students. There should be NO PARENT OR STUDENT observations in classrooms, but will be considered on a per basis issue (example: Grandmother in town, 1st time visitor, etc.).

ABSENCES/TARDIES: Please arrive on time and attend each class. Students are granted 3 unexcused absences per half season and unlimited excused absences(school event, doctor/dentist visits, sickness or injury, and church events). If a student misses more than 6 classes, excused or unexcused, he or she may be required to take a private lesson with his/her instructor at \$20 per 30 min private lesson. Please direct message through the studio app or send an email if a student will be missing class due to an excused event. Absences and tardiness can hold back an entire class. Students that keep a perfect attendance all season will receive a medal on stage at recital.

REFERRAL CREDITS: Refer a friend and upon their registration you will receive a \$10 credit for every friend that signs up! \$10 credit can go towards tuition or costumes!! (For new members that register only).
