Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rule of mediation is not successful in resolving the entire dispute or is unavailable, any outstanding issues will be submitted to final and binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and judgement may be entered upon it any court having proper jurisdiction.
